CALL TO ORDER

Ms. Wilson called the meeting to order at 10:03 a.m.

REVIEW OF MINUTES

A motion was made by Ms. Guilbert, second by Ms. Schaeffer, to approve the October 28, 2013 meeting minutes. The motion was unanimously carried.

UNFINISHED BUSINESS

Review and Signing of Consent Agreement

A motion was made by Ms. Wilson, second by Ms. Schaffer to approve the revised consent agreement of Edward Gillespie. The motion was unanimously carried.

Re-Review of Applications

A motion was made by Ms. Jones, second by Ms. Schaeffer to propose to deny the cosmetology application of To Gip and the nail technician applications of Tom Duong and Kao Khennarath due to lack of experience immediately preceding their applications. The motion was unanimously carried.

A motion was made by Ms. Jones, second by Ms. Schaeffer to approve the cosmetologist application of Jillian Adcock and the Salon/Shop application of Affordable Hair Extensions. The motion was unanimously carried

A motion was made my Ms. Wilson, second by Ms. Jones to approve the submission of 1,932 hours of apprentice work completed by MaryJane Igwe. Ms. Igwe was approved to submit a new page without anything crossed off as well as paystubs and/or W2's from the date range of the apprenticeship. The motion was unanimously carried.

A motion was made by Ms. Jones, second by Ms. Schaeffer to table the nail technician application of Hien Thi Bui while her current Florida license coverage was researched. The motion was unanimously carried.

Propose To Deny Hearing of Dung Chenh

Ms. Kelly called the hearing to order at 10:04a and stated that today's hearing was a result of the Boards proposal to deny the Aesthetician application of Dung Chehn. Board members were introduced, and Ms. Kelly presented Board exhibit #1 as the application and correspondence leading up to today's hearing, and Board exhibit #2 as the applicants' previous disciplinary order. Ms. Chehn was sworn in.

Ms. Chehn stated that in all of her years as a nail technician and aesthetician, this was the first time (2012 revocation) she had ever had a problem.

At 10:25a Ms. Chehn called her first witness, Christina Lee. Ms. Lee was sworn in and stated under oath that she has been a long time client of Ms. Chehn, getting eyebrow waxing, manicures and pedicures from her regularly, and has never once had a problem with her services.

Deliberations began at 10:31a. After review of the 2012 order and hearing testimony, the Board discussed Ms. Chehn taking refresher courses in waxing.

At 10:36a Ms. Chehn was called back to the stand to discuss the 2012 Order's charges in reference to eyelash work. Ms. Sherwin asked if she was certified in eyelash work, and if so when? Ms. Chehn stated that she was certified to do eyelashes 5 years ago, and waxing 3 years ago. However, she does not currently offer eyelash services because her insurance policy does not cover the procedure.

The Board went back into deliberations at 10:40a, again discussing a refresher course in waxing. A motion was made by Ms. Wilson, second by Ms. Schaeffer, to continue the proposal to deny hearing of Dung Chehn pending her completion of refresher/continuing education in waxing. The motion was unanimously carried.

The hearing went off record and adjourned at 10:49a. Verbatim testimony was taken by audio recording.

Propose To Deny Hearing of Ann Vu

Ms. Kelly called the hearing to order at 10:51a and stated that today's hearing was a result of the Boards proposal to deny the nail technician application of Ann Vu. Board members were introduced, and Ms. Kelly presented Board exhibit #1 as the correspondence leading up to today's hearing, and Board exhibit #2 as the application and supporting documents. Ms. Vu was sworn in.

Ms. Vu stated that she supplemented her application with the W2's as requested by the Board, not sure why she was still being denied?

Ms. Sherwin questioned where she was employed from August 2010 – March 2013?? Ms. Vu replied that she only worked 3-4 months in the state of Maryland in 2012, and not at all in 2013.

The Board went into deliberations at 11:12a. The W2's submitted were not all from a nail shop/salon, some from a farm, so not an indication of working in the profession immediately preceding application.

A motion was made by Ms. Wilson, second by Ms. Guilbert to continue the hearing once Ms. Vu has received certified verification of employment from her Maryland employer for the dates between August 2010 – December 2012. Ms. Vu was also reminded that she does not have a license to practice in the state of Delaware. The motion was unanimously carried.

The hearing went off record and adjourned at 11:20a. Verbatim testimony was taken by audio recording.

Propose To Deny Hearing of Melissa Clarke

Ms. Kelly called the hearing to order at 11:34a and stated that today's hearing was a result of the Boards proposal to deny the cosmetology application of Melissa Clarke. Board members were introduced, and Ms. Kelly presented Board exhibit #1 as the correspondence leading up to today's hearing, and Board exhibit #2 as the application and supporting documents, and Respondent exhibit #1 letters of character reference. Ms. Clarke was sworn in.

Ms. Clarke stated that she has been a licensed cosmetologist in good standing for 25 years. She is very anxious to get back to work and feels that she deserves a Delaware license. Ms. Clarke went on to say that she stopped working in March 2012 to prepare for her family's move to Delaware in October 2012.

The Board went into deliberations at 11:52a. Ms. Le, Ms. Jones, and Ms. Reid all agreed that the definition of reciprocity in regards to "immediately preceding" was often misunderstood by applicants and should be better defined in the rules and regulations governing the profession.

At 11:57a Ms. Newman was sworn in and testified that Ms. Clarke could reactivate her Connecticut license and reapply by Method 1, or send her transcripts directly from the school to the Board for evaluation to see if hours are comparable, or she could test out at a school rather than go back to apprentice. Ms. Clarke stated she was willing to test to gain licensure.

A motion was made by Ms. Sherwin, second by Ms. Lord to allow Ms. Clarke to withdraw her current application and to reapply after gathering information from the other states where she was licensed. A time frame of 6 months was granted to complete the process. The motion was unanimously carried.

The hearing went off record and adjourned at 12:17p. Verbatim testimony was taken by audio recording.

Propose To Deny Hearing of Ramon Ruffin

A motion was made by Ms. Wilson, second by Ms. Jones to continue the propose to deny hearing of Ramon Ruffin until January 27, 2014 for his failure to appear. The motion was unanimously carried.
