

**A REGULAR MEETING  
OF  
THE PUBLIC SERVICE COMMISSION**

1. A Regular Meeting was called to order by Chair Winslow in the Hearing Room, 861 Silver Lake Boulevard, Dover, Delaware, on Tuesday, June 7, 2016, at 1:00 p.m. with the following Commissioners in attendance: Joann Conaway, Mike Karia, Harold Gray, and Kim Drexler.

A motion was made by Commissioner Conaway and seconded by Commissioner Drexler to adopt Order No. 8899 as presented; motion carried unanimously.

A verbatim transcript was made of this proceeding.

5. DIRECTOR'S COMMENTS:

Mr. Howatt introduced John Farber to discuss with the Commission a proposed letter that Staff is recommending to be sent to the PJM Board concerning the Artificial Island project regarding what was recognized and what has been recognized by PJM at the Technical Conference. Mr. Farber requested the Commission to accept Staff's recommendation to send letter and how the Commission would like to proceed to include the Maryland Public Service Commission to either support or join in on the letter before sending to the Board.

A motion was made by Commissioner Gray and seconded by Commissioner Conaway to approve Staff's request to communicate with the PJM Board on the action presently pending at FERC; motion carried unanimously.

Mr. Farber clarified on how the Commission would prefer to include the Maryland Public Service Commission by either joining in Staff's letter or by filing a separate letter in support. The Commission stated that however the Maryland Public Service Commission prefers to file, either way, they would appreciate their support.

A verbatim transcript was made of this proceeding.

John Farber also discussed with the Commission the latest developments in the settlement discussions for FERC Docket No. EL05-121 regarding cost responsibility for required transmission enhancements planned to operate at or above 500 kV that the PJM Board approved prior to February 1, 2013.

Before entering into Executive Session Chair Winslow introduced Thomas Noyes who stated that Delmarva Power & Light's SREC Auction would be held May 31, 2016 thru June 10, 2016.

A motion was made by Commissioner Drexler to convene into Executive Session seconded by Commissioner Conaway to discuss strategies with respect to confidential settlement negotiations related to pending litigation in FERC Docket No. EL05-121; the motion carried unanimously.

A motion was made by Commissioner Gray and seconded by Commissioner Karia to reconvene to Public Session; the motion carried unanimously.

A motion was made by Commissioner Gray and seconded by Commissioner Conaway to participate as in the settlement agreement as a non-opposing party; the motion carried unanimously.

A verbatim transcript was made of this proceeding.

Mr. Howatt announced there would be a second Workshop to be held on June 15, 2016 regarding Docket No. 16-0295, "Good Faith Effort to make Payments" at 10:00 A.M. at the Dover Office.

Mr. Howatt announced the next Commissioner meeting would be held on Tuesday, June 28, 2016 at the Dover office.

Commissioner Gray voiced concern regarding customers who would be impacted by "Good Faith Effort to make Payments" in Wilmington and Northern Delaware areas. He asked if there were any statistics on persons or customers, especially in the Wilmington or Northern Delaware area who experienced these problems, in such a way that Staff might consider having some of these hearings in Wilmington. Mr. Howatt indicated that the PSC would be holding public comment sessions in several locations that would reach those customers when the Commission took action on the docket.

There was no further business and the meeting adjourned approximately at 2:07 p.m.
