Mr. Faulkner moved, seconded by Mr. Gajdos, to accept the proposed changes as amended to the 2016 Paramedic Standing Orders, Guidelines and Policies. Motion passed unanimously.

Dr. Megargel informed the Committee that the 2016 Paramedic Standing Orders, Guidelines and Policies would be submitted to the Board of Medical Licensure and Discipline for their consideration and approval. The Board's next meeting is scheduled for April 4, 2017.
