**A) Opening**

**1. Call to Order**

The meeting was called to order at 9:06 a.m. by Chairperson Gary Cimaglia.

**2. Roll Call**

**3. Approval of Agenda**

The Committee discussed amending the agenda to add one item: Recognition of Officials' Associations, Required Use of Officials and Attendance at Rules Clinics (1009-8.0) and remove two items: Waiver Request Process and Documentation from Sending School under Transfer Rule.

Mr. Hart made a motion to approve the agenda as amended. Mr. Harvey seconded the motion. The motion carried unanimously, 9 – 0 (Cimaglia, Coffing, Corrado, Edney, Fitzgerald, Hart, Harvey, Holloway, and Tyndall).

**4. Approval of May 24, 2017 Minutes**

Dr. Fitzgerald made a motion to approve the minutes from the January 26, 2017 meeting. Mr. Hart seconded the motion. The motion carried unanimously, 6 – 0 (Cimaglia, Fitzgerald, Hart, Harvey, Tyndall, and Wagner), with 4 members abstaining from voting (Coffing, Corrado, Edney, and Holloway).
