Review of Internship Completion

Review of Reciprocity Application(s)

The Board reviewed the Reciprocity application submitted by Chelsea Ryzuk. Dr. Brown, made a motion, seconded by Dr. Miller to PTD the application based on:

§ 2109 Reciprocity.

The Board shall waive the internship requirement for an applicant holding a valid license to practice optometry issued by another jurisdiction and who has practiced for a minimum of 5 years in such other jurisdiction with standards of licensure which are equal to or greater than those of this chapter and grant a license by reciprocity to such applicant.

By unanimous vote, the motion carried.

Discussion of Proposed Changes to TeleHealth regulations as proposed by the DE Optometric Association

The Board members discussed changes/additions to the Board of Examiners in Optometry TeleHealth regulations. Dr. Biddle, made a motion, seconded by Dr. Miller to approve the changes and hold a Rules & Regulations Hearing at the April 12, 2018 Board Meeting. By unanimous vote, the motion carried.

Discussion of potential regulations to clarify 24 Del. C. §2113(a)(6)

The Board briefly discussed the potential regulations to clarify 24 Del. C. §2113(a)(6). Dr. Miller, made a motion, seconded by Dr. Biddle to table any further discussion until the April 12, 2018 Board meeting.

The members of the Board discussed the letter submitted by Stella Ohanenye, O.D. concerning whether or not Delaware Optometrists can prescribe Latisse. The Board members agreed that according to: § 2101 Definition of practice of optometry, a Delaware Licensed Therapeutic Optometrist can prescribe Latisse.

PUBLIC COMMENT

Deborah Hamilton thanked the members of the Board for their taking into consideration and discussion concerning Changes to the TeleHealth regulations.

Carine Tata approached the Board to inquire about Reciprocity requirements for licensure as a Therapeutic Optometrist in Delaware. The board informed Ms. Tata that based on her qualifications and current supervision that at this time she does not qualify for licensure by Reciprocity in Delaware.
