6. PUBLIC COMMENTS

Kelly Williams, Commissioner of Public Works for the City of Wilmington, made the Commission aware of the public’s concern with Delmarva Power’s quality of work in the city following a busted watermain caused by their subcontractor (Willbros). She expressed that with the majority of road cut permits being granted to Delmarva, the city does not have enough staff to monitor Delmarva’s quality of work on every project.

7. DIRECTOR'S COMMENTS

Marisa Slaten from Delmarva Power & Light discussed March 1, 2018 water service strike in Wilmington, which was related to the public comment made by Kelly Williams, Commissioner of Public Works for the City of Wilmington. Ms. Slaten introduced staff from Delmarva's Subcontractor's, Willbros, which included Greg Nettles, Kristin Stanfill, Richard Walker, and Robert Kitson. Willbros staff presented a power point presentation to the commission and attempted to explain the scenario which resulted in the watermain break in the City of Wilmington. Commissioner Gray asked Delmarva Power & Light, WillBros, and Kelly Williams, Commissioner of Public Works for the City of Wilmington, to explain to the Commission how they plan to work together to prevent future issues and fix the current issues.

Delmarva Power & Light updated the Commission on the company's Critical Infrastructure Protection plan. The Commission entered into executive session for this presentation.

Mr. DeLosa updated the commission on various PJM/FERC/federal issues which included FirstEnergy Solutions 202(c) filing at the Department of Energy and PJM Capacity Construct Filing.

Mr. Hartigan announced that Chairman Winslow is to address PHI Board Meeting on May 8, 2018 at 9:00 A.M.

Mr. Hartigan announced the Evidentiary Hearing for PSC Docket 17-0985, Delmarva Power & Light Energy Efficiency Programs scheduled May 8, 2018 at 1:00 P.M. was cancelled.

Mr. Hartigan announced that the next Commission meeting would be Tuesday May 8, 2018 at the Dover office.
