MINUTES

Certification of the September 6, 2018 Primary Election

The meeting was called to order at 1:05 p.m. (EDT) in the Department of Elections, New Castle County Office.

Those present: Elaine Manlove, State Election Commissioner; Anthony J. Albence, County Director; and Howard G. Sholl, Jr., Deputy County Director.

Mr Albence and Mr Sholl submitted the updated results for the September 6th Primary to Ms. Manlove.

Mr Sholl reported that the results reported on Election Night were adjusted as follows:

- 2 votes were added from Provisional Ballots for Mr. Carper;
- 1 vote each was added for Ms Harris, Mr. Johnson and Ms. Davies from a cartridge that failed at the Park View;
- And, 1 vote each for Mr. Truono and Mr. Walker from a cartridge that failed at the Townsend Early Childhood Education Center.

The New Castle County Office received 20 Provisional ballots, 2 of which were counted. The others failed to meet the criteria to be counted.

When a cartridge fails the results read from that cartridge in many instances are incorrect. In both instances noted above the machines were taken out of service and the results recorded in the machine were extracted using a Service Code. The results reported from the cartridge and the machine were compared and the appropriate adjustments were made as noted above.

Mr Sholl reported that the Department received 2, 868 voted absentee ballots before 8 p.m. on Election Day. 2,861 of those were counted. The reasons that ballots were not counted are listed below:

- 1 ballot because there were 2 ballots in the envelope,
- 2 ballots because the oath was signed by a POA, and
- 4 ballots because the oath was not signed.

Ms Manlove reviewed the FOIA request from Tori Ann Parker and decided to take no action at this time. Ms Parker will be provided the list of persons who voted in the Primary when the data is available.


