CALL TO ORDER

Dr. Williams called the meeting to order at 9:12 a.m. Dr. Williams welcomed Ms. Prameela Kaza, Public Member to the Board of Nursing.

Dr. Zickafoose gave an update on the new online licensure system DELPROS.

DISPOSITION OF MINUTES

Meeting Minutes – November 14, 2018

The Board reviewed the minutes of the November 14, 2018 meeting. Ms. Bastholm moved, seconded by Mr. Hare, to approve the minutes as presented. The motion carried with Ms. Kaza abstaining.

ADOPTION OF THE AGENDA

Mr. Hare moved, seconded by Mr. Brown, to adopt the agenda. The motion carried unanimously.

ACTIVITIES REPORT

Dr. Zickafoose reported the number and types of active licenses as of January 9, 2019.

UNFINISHED BUSINESS

eNLC Rules Adoption Hearing

Ms. Singh read a supporting document submitted by Nemours on November 28, 2018. Ms. Udealer moved, seconded by Ms. Bastholm to adopt the amendment to revise the regulations to bring them into conformity with the current eNLC.

APRN COMMITTEE

Dr. Castaldo reported the APRN committee was rescheduled for January 14, 2019. On January 3, 2019 the APRN Sub-committee completed a draft General Assembly report. There were 126 independent applications approved in all 4 of the APRN roles with no disciplinary actions. This report is a requirement of the 2015 legislation for the APRN Consensus Model which included eligibility for full practice authority and independent practice. This report is due in September 2019 and will be reviewed and signed by the Board of Nursing and the Board of Medical Licensure & Discipline president before being submitted to the General Assembly.

PRACTICE AND EDUCATION COMMITTEE

Ms. Bastholm reported the committee met on December 13, 2018. Ms. Bastholm moved, seconded by Mr. Hare, to change the rules so they state up to 50% per course can be substituted with high fidelity simulation. The motion passed unanimously.

Ms. Bastholm reported all Delaware nursing schools end of year reports were received and complete. All Delaware nursing schools met the 80% pass rate, except for Adoni Health Institute. Ms. Bastholm moved, seconded by Ms. Benson, to grant all Delaware nursing schools with full approval of continued full approval for one year, except for Adoni Health Institute. The motion passed unanimously.

Ms. Bastholm reported Adoni submitted their end of year report, however no data was provided under the survey section, so members could not ascertain the attainment of the program of student outcomes. Additional documents were requested. Adoni Health Institute also submitted the Corrective Action Plan (CAP), however no data was provided to determine if the objectives were met. Outcome data was requested to be submitted no later than March 1, 2019. Ms. Bastholm moved, seconded by Mr. Hare, to table any action on Adoni Health Institute until March 1, 2019.

Ms. Bastholm reported there are currently no LPN refresher courses available and they are needed. Polytech is considering starting an LPN refresher course.

LLAM COMMITTEE

Dr. Zickafoose reported the committee met on December 18, 2019. The purpose was to reconvene the committee since they had not met since September 2016 and to review the annual reports as required by the 2015 legislation for LLAM. Annual reports were reviewed from

all the entities. The data showed 2,784 unlicensed assisted personnel were trained in 2018 and 14 medication errors were reported. Additional information on error rates is being requested from the Division of Healthcare Quality Long-term Care Residents Protection. Two representatives from DDDS were present and the document they submitted was reviewed. There was a motion to amend the language on the cover page of the LLAM Policy & Procedures Manual so it reads “adapted” instead of “adopted”. The committee discussed the use of Diastat and stated it is an emergency medication listed underneath the nursing statute and is not included in LLAM’s core curriculum. The committee agreed it is an entity specific modification that is acceptable. DDDS requested additional versions of the LLAM exam/quizzes and proposed an exam for initial LLAM status and a different exam for renewal. Dr. Zickafoose requested if anyone with knowledge of LLAM to submit questions for consideration.

Dr. Williams inquired regarding the Share the Care Bill and Dr. Zickafoose replied there was a future stakeholder meeting scheduled.

PRESIDENT’S REPORT

Dr. Williams reported in the Gallop Poll that nurses ranked highest as the most trusted profession in honesty and ethics for the 17th consecutive year. The National Council of State Boards of Nursing (NCSBN) released a new publication called the, *Front Line of defense: The Role of Nurses in Preventing Sentinel Events*. The article stated that nurses are essential to prevention and identification of situations that would rise to a level of a sentinel event.

The University of Delaware is leading the initiative of the Delaware Nursing Leadership Group which is a continuation of the Action Coalition – Future of Nursing. They meet on a regular basis and are planning a summit in the spring for nurses across the state of Delaware. Barbara Habermann and Rita Landgraf of University of Delaware chair the Delaware Nursing Leadership Group.

Dr. Williams reported the APRN Compact Work Group was newly established by the NCSBN to review the APRN Compact which is similar to the compact model for RN’s. There will be an update after the mid-year meeting in March.

EXECUTIVE DIRECTOR’S REPORT

Dr. Zickafoose discussed workforce data which will be collected by DELPROS. Workforce questions will be embedded in the new licensure system.

Dr. Zickafoose reported 1,748 RN/APRN renewals were emailed which is the smallest group of renewals for this year. APRN’s with a certification that is outdated or is set to expire have been contacted and are not eligible to renew until we receive their individual certifications. The next renewal date will be in May 2019 which will be our second largest group, and the last renewal for this year, the largest group, will be in September.

Dr. Zickafoose reported the NCSBN mid-year meeting will take place March 26th – 28th located in San Antonio, TX. If anyone is interested in attending please let her know. She reported there

are now 9 states with potential legislation for the eNLC Compact. The states are Pennsylvania, Illinois, Indiana, Massachusetts, Michigan, Nevada, New Jersey, Rhode Island and Washington. Dr. Zickafoose informed the Board that an applicant had communicated she was informed by the SBI her criminal background check (CBC) may take longer than usual due to the government shutdown. This was discussed with the NLC and the attorney for the NLC said there is language in the bylaws or rules that could possibly enact an emergency rule making procedure to allow a temporary permit. Several states including Delaware are not allowed to issue a temporary permit without the CBC.

Dr. Zickafoose reported the NLC has planned another strategic planning retreat for February 22-23, 2019 located in Dallas, TX and she has requested to attend. Continuing education provider renewals were due as of January 1, 2019. Dr. Zickafoose and Ms. Singh are scheduled to attend the Attorney/Executive Director workshop in Nashville, TN on January 29, 2019. The Maryland Board of Nursing received applications from several fraudulent nursing programs. Therefore, the Maryland Board of Nursing education staff will review every applicant's education program to ensure equivalency to the education offered in Maryland.

NEW BUSINESS BEFORE THE BOARD

Licensee Applicant Reviews

Victor Vasquez, GN (Conviction)

Mr. Vazquez graduated from Delaware Technical Community College in December 2018. His CBC showed he was convicted of Assault Third Degree-Intentionally Recklessly Cause Physical Injury in June 2005. He submitted a letter of explanation and court documents along with letters of reference. Ms. Bastholm moved, seconded by Dr. Castaldo, to grant a waiver for licensure by examination. The motion carried unanimously.

Laura Bachmann, RN (Discipline in IL)

Ms. Bachmann graduated from Evanston School of Nursing in August of 1984. She marked yes to question #18 (which asks, "if any of her nursing licenses have been disciplined") and wrote in "Illinois". She submitted a letter of explanation. The IL Board Order shows the student loan was paid in full and probation of her license was terminated on June 19, 2003. Ms. Udealer moved, seconded by Mr. Hare, to grant a waiver for licensure by endorsement. The motion carried unanimously.

Scott Seres, RN (Dependency)

Mr. Seres graduated from Brandywine School of Nursing in May of 2010. He marked yes to question #24 (which asks, "Are you now, or have you ever been, dependent on the use of alcohol, stimulants, or habit-forming drugs?") and wrote "enrolled in PNAP (PA PHMP) since June 2016. The criminal background check shows Mr. Seres was convicted of a DUI on February 2009 in New Hampshire. Mr. Seres was granted a Temporary Permit on 09/12/2018 which is set to expire on 02/11/2019. Mr. Salati moved, seconded by Mr. Hare, to grant a waiver for licensure by endorsement pending Mr. Seres consent to DPHMP co-monitoring. The motion carried unanimously.

Regina Garnett, LPN (Conviction)

Ms. Garnett graduated from Pennsylvania Institute of Technology in June 2017. She was convicted of Offensive Touching of Another with Saliva, Urine, Feces or Other Bodily Fluid in March 2014. She submitted a letter of explanation. Ms. Udealer moved, seconded by Ms. Benson, to grant a waiver for licensure by endorsement. The motion carried unanimously.

Ramona Negron, RN (Dependency)

Ms. Negron graduated from Delaware Technical Community College in May 2003. Her criminal background check shows she was convicted of theft in October 1995 and a felony DUI in January 2018. She submitted a letter of explanation. Mr. Salati moved, seconded by Mr. Brown, to propose to deny licensure by reinstatement. The motion carried unanimously.
