### **Review of Reciprocity Applications**

A motion was made by Ms. Davis, seconded by Mr. Reed to table the application of Ms. Torres for lacking verification of 1 full year of work experience gained after original licensure. The motions pass unanimously.

Board reviewed application and determined that Ms. Wengreen was originally licensed in the State of Colorado which is substantially similar to the State of Delaware. Therefore, this application is considered Fast track and does not require Board review for license issuance.

A motion was made by Ms. Davis, seconded by Ms. Deo to approve the application for Ms. Frazier contingent upon receipt of an employer written Work Experience Affidavit. The affidavit must verify 1 full year of employment and provide Ms. Fraziers employment start and end date. The motion carried unanimously.

### **Miscellaneous Review & Discussion**

#### **Practical and Theory Testing**

Ms. Ridgway advised the Board how the COVID-19 pandemic has affected Delaware Cosmetology schools and students. The delay in testing ability has negatively affected Delaware schools and students causing an influx in complaints to DPR and the Schools directly. Mr. Juan DeJesus, public attendee, advised that all States that do not utilize PCS testing services have resumed Theory and Practical testing of recent graduates.

Ms. Ridgway explained that in correspondence with PCS, the problem has been attributed to COVID-19 social distancing policies. PCS's current practical examination center is not large enough to accommodate the new recommended social distancing requirements, prompting a few Delaware Schools to offer their sites for practical examination centers. PCS has advised that theory examinations will be restarting in October. DPR, Division Director, Geoff Christ has contacted the PCS CEO to offer our assistance in making sure that the examinations can begin again soon. The Board also expressed concern that when testing begins there will be a large backlog of exam candidates.

Ms. Ridgway advised the Board that DPR has identified all temporary permit holders and is working to extend the permits to allow the permit holders time to test before their permits would expire.

Shauntee, public attendee- recent school graduate, addressed the Board and explained that recent graduates are having difficulty finding employment because most salons require that graduates have begun testing before signing for a temporary permit.

Ms. Kelly advised the Board that she would work with DPR to identify terms of the States contract with PCS and assist in ensuring there is a plan in place to start testing.

#### Distance Education – Possible Covid Extension

Mr. Cook advised the Board that distance education is currently written to expire on December 31, 2020. Mr. Cook explained that Utah and other States have already begun to review their current distance education policies and to extend the availability dates into 2021 as we are still in a pandemic. Ms. Kelly advised the Board that she would contact the DPR Division Director to request an extension to our current Distance Education policy.

#### **PUBLIC COMMENT**

Juan DeJesus, public attendee, addressed the Board and suggested allowing Delaware schools to sign off on graduates practical examinations similar to other States. Mr. De Jesus suggested that if Delaware did not require a practical examination, graduates may be able to enter to work force sooner. Mr. Cook advised Mr. DeJesus that the Board will be looking into other States testing requirements.

#### **NEXT SCHEDULED MEETING**

The next Board meeting will be held on Monday, October 26, 2020 at 9:00 a.m. via teleconference.

#### **ADJOURNMENT**

With no further business before the Board, a motion was made by Mr. Barnes, seconded by Mr. Reed, to adjourn the meeting. The motion carried unanimously. The meeting adjourned and went off record at 10:14 a.m.
