Topic 4: Committee Discussion on Goal: Data Driven Approach to Improve Outcomes

Update on Community Based Recidivism Program

- Little to no data from courts that represent if the reentry programs are working.
- Unsure of the length of the reentry programs
- The goal of gaining data from the reentry programs is to make the system better after inmates are released.
- Open loop problem
 - The loopholes are not going to be closed in one step.
 - Need to anticipate the problem and close the gaps.
- Outcome data for recidivism is crucial and quality of life data is important to be considered as well (employment, housing, mental health).
- Concern that funding is going to programs that are not effective. Desire to promote and fund programs that are effective.
- Establish a possible partnership with other groups that are working on recidivism.
- DSAMH is beginning to look at overdoes death and may have connected with PDP services.

- Focus on once that person goes to PDP and receives services, where are they a year from that moment.

Topic 5: Sussex Drug Court Changes Update

Presenter - Co-chair Chuck Sawchenko

- In Sussex drug court, IT is working to get individuals with substance abuse to drug court within 2 weeks.
- A peer from DSAMH was added to the drug court to assist with behavioral health services.
- The court works towards getting people into treatment.
- Putting together for Sussex county to implement the same changes that took place in the New Castle county courts
