Topics 1: Welcome and Introductions

Presenter – Laura Rapp

- Laura Rapp called the meeting to order.
- Laura Rapp greeted and welcomed attendees.
- Co-Chairs Dr. Sandy Gibney and Erin Booker are absent.

Topic 2: Review and Approve Minutes

MOTION: Laura Rapp called for a motion to approve the minutes from the previous meeting.

- Dr. Doug Tynan made a motion to approve the minutes from the previous meeting.
- Dr. Avani Virani seconded the motion.
- Minutes approved.

Topic 3: Delaware Naloxone Saturation Plan with Multiple Assignment

Presenter – Brent Waninger

- The previous Naloxone dissemination plan funded through SOR was developed without much evidence-based/research-based planning outside of a review of practices implemented by neighboring states.
- More recently, SAMHSA recommended working with a SME to develop a data driven saturation plan, which DSAMH did. The new plan was co-developed by the SME with DSAMH providing input about Delaware specific context.
- With this change in plan, there will now be a 3-fold increase in Narcan in Delaware via SOR funding with an estimated 60,413 high-yield kits.
- 3 categories of distribution
 - o High-yield
 - o Mid-yield
 - o Low-yield
- Research tells that the high yields are the most effective ways to get kits to where they need to be at the time of incident.
- Methods have highest yielding impact in getting the kit at the overdose site.
- High-yield examples include emergency departments and directed clients.

- Mid-yield examples include treatment providers and facility use.
- Low-yield examples include community providers and mail order programs.

Topic 4: Goal 2: Update on Raising Awareness of Xylazine: Identifying Xylazine Provider Resources/Training Needed Partnership with DSAMH

- Topics compiled include.
 - Wound related topics.
 - Stigma on wound care
 - Consistency in wound care cleaning
 - Identifying wound early
 - Changing wound dressing
 - Information on how quickly wounds can progress.
- Education on how Xylazine overdoses are different--person is hard to rouse.
- Emphasizing how it is not just overdoses that are causing death but dying from infection as well.

Topic 5: BHC Running Updates

Presenter –Laura Rapp and Alexia Wolf

- The Education and Prevention Committee and the Changing Perceptions and Stigma Committee are collaborating for fentanyl awareness day/raising awareness for fentanyl.
- Relevant notes from listening sessions
 - Workforce shortages
 - Long waitlists
 - Knowing what type of provider is most appropriate.
 - Secondary navigation of insurance and coverage
 - Youth specific: parental engagement with services that may only be offered during the workday.
- Recovery Friendly Workplace Initiative: working on framework for project and will provide updates.

Topic 6: Public Comment

- Dr. Doug Tynan mentioned breach of Change Healthcare that occurred on February 21st. Private practices are having a difficult time submitting claims and getting paid; clinicians may be laid off.
- Trish Hill mentioned patients having a difficult time navigating access to mental health providers. Participants are having trouble finding mental health services and are unsure where to turn.
- Peggy Geisler mentioned a basketball game occurring on March 21st and there may be availability for vendors to have tables.
- Reminder that the Delaware Rural Health Conference is being held on May 30th and is being organized by the Sussex County Health Coalition.
