## **Topic 3: BHC Updates**

#### Presenter – Laura Rapp

- The Education and Prevention Committee has a goal of promoting and supporting behavioral health prevention education campaigns, cross committee collaboration with the Changing Perceptions and Stigma Committee.
- The Family and Community Readiness Committee has a goal to develop strategies that protect a person's autonomy to direct their own care while experiencing a mental health crisis. The goal is steadily moving forward with the end goal being proposed to legislation.
- Relevant notes from listening sessions.
- Participants attending Delaware State University and the University of Delaware listening sessions shared their thoughts and experiences.
  - o Students are aware of multiple resources on campus. However, experiences are varied,
  - Race/ethnicity and gender are important factors in selecting a provider. When there is incongruence, the individual may feel that they have to "orient" the provider to their culture.
  - Though shared demographics influence the selection process, they do not guarantee a "fit". Participants found that a provider's willingness to listen, to create nonjudgmental spaces, and practice empathy fostered relationships that proved helpful.

## **Topic 4: Updates on the Recovery Friendly Workplace Initiative**

#### Presenter—Annie Slease

• Working with the National Governor's Association along with 3 other states (Maryland, Minnesota, and Missouri) on a plan to bring the Recovery Friendly Workplace Initiative to Delaware

- The initiative is about engaging employers related to SUD and recovery.
- There's a primary focus on restaurants and construction industries.

- Met with the executive director of counseling services with Delaware State University.

- Discussed meeting in the end of June/early July.
- There were discussions about meeting in person at Buena Vista or the University of Delaware.
- Goal 2: Ensure that people with lived experiences and youth are represented on BHC Committees-Update on email survey.
- The committee decided to take out the section of the email survey that include the option for the participant to include their name.
- Goal 3: Support and advertise community stigma intervention work- Report back on Fentanyl Awareness Day activities.
- Partnering with Song for Charlie
- A video was created by youth for Fentanyl Awareness Day and the video was spread around social media to promote awareness.
- Brian Dietz from Impact Life is working on the second annual harm reduction conference. It is to take place the last week of August.
- Two recovery cafes are opening.
- Annie Slease with the Mental Health Literacy Collaborative is working on launching a tiered training initiative.
- The first tier of the training will be ready in a few weeks, and it is built around advocacy for the mental health literacy framework.
