- Opportunity—DSAMH Health Equity Advancement Project
  - DSAMH has an opportunity to engage with the Health Equity Advancement Project initiative to address local health disparities, specifically racial/ethnic minorities who are impacted by opioid use disorder.
- The Education and Prevention Committee is collaborating with the Addiction Action Committee as they have a shared interest of addressing youth consumption of cannabis and they currently are forming a workgroup.
- Update on SB 309, The Uniform Health-Care Decisions Act
  - Creates patient-directed advance mental health directives.

- Looking at a pitch deck to show to potential employers and drafting an employer guide.
