Topics 1: Welcome and Introductions

Presenter –Co-Chair Valerie Earnshaw

Topic 3: BHC Updates

Presenter – Laura Rapp and Alexia Wolf

- DSAMH is offering a mini grant to promote recovery for the month of September.
- The BHC was present at the Unity Dinners in partnership with Black Faces Black Voices on June 24th and June 25th as well as July 24th and July 25th.
- The BHC is now present on social media to provide information and updates.
- DSAMH is hosting a 2-day conference for the Health Equity Advancement Project Initiative (HEAP). The conference is September 11th and September 12th, at the DoubleTree Hotel in Wilmington and registration information is to follow.
- There is a summit on the opioid epidemic that is sponsored by the BHC and the University of Delaware on September 12th from 2:00-5:30 PM.
- Facilitators highlighted considerations from the listening sessions. These include...
 - The understanding that though individuals may have been discriminated against, they have developed resiliency and coping strategies that have allowed them to survive.
 - Community members are receptive to learning sessions that promote mental wellness and stress management skills.
 - The process of aging comes with its own unique challenges, and as such, interventions and programming for older adults should consider accessibility isolation, etc.
- The next BHC Quarterly meeting is on October 15th at 10:00 AM. It is a hybrid meeting, and the location is to be announced.

Topic 4: Updates on the Recovery Friendly Workplace Initiative

Presenter—Annie Slease

- Working with the National Governor's Association along with 3 other states (Maryland, Minnesota, and Missouri)
- Visited Baltimore for wrap up of policy academy in July.
- Maryland is going to be a good partner for the Delaware, they have ideas that Delaware can borrow.
- The pitch deck and materials for employers were polished up.
- Starting to engage with some employers who are interested in the pilot.

Topic 5: Goal Updates

- Goal 3: Support and advertise community stigma work.
- The BHC is in partnership with AB&C to launch a revamped website.
- Goal 2: Ensure that people with lived experiences and youth are represented on BHC Committee
- The survey ensuring that people with lived experiences are represented on BHC committees has been circulating.
- The survey has 6 new responses.
- The survey will close on August 24th.
- The results of the survey will be discussed in the September meeting.
- Goal 1: Collegiate Recovery Communities
- Discussion on meeting with stakeholders of higher education.
- Timing.
 - October 4th is the suicide awareness event at the University of Delaware. This may or may not be good date to meet.
 - The subcommittee is offering up Friday and Thursday mornings in late October and early November to send out to partners and see what works for them.
 - Looking to have a 3-hour hybrid meeting. The in-person location may be at Buena Vista or Warner Hall at the University of Delaware
- The frame for the meeting is supporting college students in recovery.
- 3-part agenda.
 - First part is a brief setting the stage and talking about scope of problem as well as defining key terms.
 - Second part is spotlighting solutions and sharing something that their institution is doing well.
 - The third part is to end it with networking and discussion as well as a call to action.
- Next step is to send out poll to partners to figure out a date to connect and finalize a location.

Topic 6: BHC Website Update

Presenter—Alex Parkowski of AB&C

- The objectives of this new website are as follows.
 - Provide unique web addresses for both the BHC and POSDC that stand alone and work together.
 - Create east-to-use web experience for all BHC and POSDC committee members as well as the general public.
