#### **Committee Updates**

- The Changing Perceptions and Stigma Committee has a goal to ensure individuals with lived experiences are represented at the BHC.
- The first step is an organizational assessment that will be sent out to all BHC members in the next few weeks.
- The Education and Prevention Committee had activities around Fentanyl Awareness Day on May 7<sup>th</sup>.
- These activities included putting flyers up at pharmacies to spread awareness about Fentanyl laced substances, and a video was created that was shared across social media.
- Relevant notes from listening sessions
- Listening session facilitators continue to highlight opportunities for promoting behavioral health awareness, literacy, and advocacy in families and communities. This includes.
  - Addressing stigma when experiencing, and seeking help for, behavioral health challenges
  - Connecting with providers who may offer free, or low cost, services.
  - Developing stress management, self-care, and mediation skills
  - Preventing substance use

- The State Opioid Response Conference: Innovative Strategies for Engaging Key Populations is on May 29<sup>th</sup>-May 30<sup>th</sup> at the Chase Center on the Riverfront.

#### **Topic 4: Goal 1: Update on Psychiatric Advanced Directives. Review/comments on Draft**

- Communication has been done with the legislator's office.
- Legislation was drafted.
- The Psychiatric Advanced Directives and the Medical Advanced Directives have come together to create one piece of legislation for the state of Delaware.
- This ensures that individuals can have care needs, especially in times of mental health crisis.
- The two teams have consulted with multiple organizations for input.
- Laura Rapp will send out information on the legislation once they get clarification on some of the questions the committee members asked.
