- Mission is to serve survivors of human trafficking to achieve life changing goals in professional and academic settings and educate the community in awareness and prevention of human trafficking.

- Low barrier education scholarships, employment readiness
- \circ Rental assistance
- o 28 survivors received long-term mental therapeutic support.
- 95% of survivors are experiencing mental health challenges.

EP10 Update

• Sandi talked with the Colonial School District and Nemours to pilot the EP10 program pilot. Unfortunately, the school district is unable to continue with the pilot at this time but they are open to discussing it again for the next school year.

Fentanyl Awareness Day Workgroup Update

- Mission is to share a youth created video to bring awareness to Fentanyl Awareness Day. The committee is encouraged to post the video on their social media and send the video to others.
- Dispose RX and prevention playbooks are being sent out to school nurses in Delaware and signs will be provided to be posted around the schools.

Cannabis Gummy Workgroup Update

- The group met with the Addiction Committee Primary Prevention Co-Chairs.
- The AAC is creating a substance use prevention plan.
- Could do lessons learned from other states that legalized marijuana sooner.

Non-Pharmacological Pain Management Workgroup Update

• A workshop directed towards mental health clinicians by the American Psychological Association is taking place in the fall.

- Formation of focus on prevention messaging and shared alignment
- The Primary Prevention subcommittee looked at emerging substances as well as identified barriers and problems.
- They are beginning to look at parts of the prevention plan that need to be adjusted and to make sure the plan aligns with the trends being seen as well as what trends the data is showing.

DSCYF—Joyce Hawkins

- Building Bridges Conference was last week.
- A keynote speaker discussed the effects of THC on youth and the impacts of marijuana on the brain.
- There is a need to educate and encourage caregivers to be responsible at home now that marijuana is legalized.
