## **Topics 1: Welcome and Introductions**

## Presenter – Co-Chair Rebecca King

## **Topic 3: BHC Updates**

#### Presenter – Alexia Wolf

- The Changing Perceptions and Stigma Committee has a goal of incorporating those with lived experiences in the BHC. The committee has developed an organizational assessment to see where the BHC stands. The email should be coming out in the next few weeks.
- Relevant notes from listening sessions
  - During the listening sessions, participants expressed the need for, and perceived benefit of, learning opportunities. These include.
    - As a means of reducing stigma about different groups (i.e., immigrants)
    - As a means of reducing stigma within groups (i.e., challenging unhealthy norms.)
    - To promote self-advocacy when engaging with professionals and systems.
    - In support of resiliency building and communication skill development.

## **Topic 4: Youth Prevention Day**

## Presenter – Scott Michels, The CAUSE

- Part of Delaware's Prevention Partners
- 9 providers and 36 youth were present.
- Some of the youth mentioned that the prevention efforts are targeted more towards high schoolers, but they mentioned more efforts for younger students such as middle schoolers.

- Governor Carney proclaimed May 15<sup>th</sup> as Youth Prevention Day
- The students were recognized on the floor of the house.
- The next event the CAUSE is hosting is the Do-Good-A-Thon
- It is a 2-month movement.
- The idea is to see how many people they can get to do at least one act of service for others.
- The PARTY 4 is on July 27<sup>th</sup> at the Delaware Contemporary from 4:00PM-7:00PM. There are opportunities for different organizations to host tables and encourage individuals to do an act of service at the table.

### **Topic 5: Discussion on Alcohol**

#### Presenter – Rebecca Uniatowski

- There is more of a focus on drug overdoses instead of the dangers of alcohol.
- Many people don't discuss how withdrawal from alcohol can cause death.
- More education and prevention efforts should be geared towards alcohol use and the dangers of it. A large goal of this is to include the warning that alcohol is addictive on the label of products containing alcohol.
