### **Topic 1: Welcome and Introductions**

#### Presenter – Lt Governor Hall-Long

- Lt Governor Hall-Long called the meeting to order.
- Lt Governor Hall-Long welcomed attendees.

### **Topic 2: Announcements and Approval of Minutes**

**MOTION:** Lt. Governor Hall-Long called for a motion to approve the minutes from the previous meeting.

- Dr. Debra Mason made a motion to approve the minutes from the April 16, 2024 meeting.
- Emily Vera seconded the motion.
- Minutes Approved.

### **Topic 3: Story of Recovery- Unity Dinner**

### Presenter – Bishop Carol Boggerty

- The BHC collaborated with Black Faces, Black Voices to host two Unity dinners.
- One took place on June 24<sup>th</sup> in Wilmington, DE and the other took place on June 25<sup>th</sup> in Dover, DE.
- There was a great turnout from the community and community members got a chance to share their stories and their concerns regarding behavioral health and drug use in the state of Delaware.
- Two more Unity dinners are to take place, on July 24<sup>th</sup> in Middletown, DE and the other on July 25<sup>th</sup> in Seaford, DE.

### **Topic 4: Public Comment**

- Calvin Davis Jr. discussed the impact of individuals experiencing homelessness in Wilmington, the lack of progress for this issue and its urgency. Mr. Davis advocated for better education of services for this population given the relevance of mental health issues.
- Rebecca Nuttall read a letter on behalf of Domenica Personti. Ms. Personti's letter, addressed her
  concerns raised by Attorney General Kathy Jenning's letter dated June 28,2024. Ms. Personti's letter
  acknowledged that the funds are designated to help those in need and if there is a delay in funding,
  the individual served may face dire consequences.
- Dave Humes voiced being in favor of approving the funds. Mr. Humes called attention to the POSDC systems that caught potential fraud and the POSDC will try to recover those funds. Mr. Humes highlighted that it is crucial to release the funds as Delawareans. Mr. Humes details of the May 28<sup>th</sup> POSDC meeting, Mr. Humes discussed that the primary purpose of the funding is to keep people alive and help people, and the funds are needed to continue to save lives.
- Senator Stephanie Hansen voiced concerns regarding the June 28, 2024 letter Attorney General Kathy Jennings sent and the importance of the funding to help people. Senator Hansen highlighted that the letter did not accurately reflect what took place in the May 28<sup>th</sup> POSDC meeting, according to the meeting minutes. Senator Hansen advocated for a deeper discussion about what is going on behind the letter.
- Peggy Geisler voiced concerns regarding the June 28, 2024 letter from Attorney General Kathy
  Jennings, and possible collateral damage to the reputations of those who have received POSDC grant
  funds.
- Jill Fredel provided a letter written on behalf of atTacK addiction, read by Alexia Wolf. Ms. Fredel's letter was in response to Attorney General Kathy Jennings's letter dated June 28, 2024. Ms. Fredel's letter emphasized their organization understands the accountability that they accept when they receive outside funding. Ms. Fredel's letter highlighted how atTacK addiction carefully monitors the funding to ensure it is being spent properly and goes to the correct places. Ms. Fredel's letter noted the intensity of the monitoring process by POSDC and advocated for approval of future funding.
- Senator Eric Buckson advocated for a halt in approving further funding until concerns regarding
  accountability could be addressed, and requested looking into long-term solutions the funding could
  support.
- Representative Kendra Johnson advocated for the funding to be released. Representative Johnson noted that the POSDC systems work, and that they do help Delawareans who are suffering.
- Dr. Cherese Godwin highlighted her support for passing the social work compact bill in Delaware. Dr. Godwin discussed that the bill represents a step forward in addressing the growing demand of social work services and the bill will greatly enhance the mobility and flexibility of workers.

## Topic 5: Presentation of Prescription Opioid Settlement Distribution Commission Recommendations for 3- month Bridge Funding for Existing Phase 1A and Phase 1B Grantees.

- 2023 was the first reduction of fatal overdoses in 10 years.
- 1.8% decrease overall (147% increase in Black and Brown Communities)
- For 2024, the reported numbers of suspected overdoses are expected to be lower than previous years.
- Available POSDC Fund Balances as of April 30th, 2024
  - O Settlement Fund Balance: \$31,599,518
  - o Impact Fee Fund Balance: \$3,370,398





   To Be Lower Than Previous Years (2022 And 2023)


## Reduction in Fatal Overdoses



#### **Acute OUD Stabilization Subcommittee Updates**

- Subcommittee has worked to strengthen relationships between EDs, EMS, and community treatment providers, and developed pathways for patients who are treated in an acute setting, initiated on buprenorphine, and referred to community treatment
- Now that relationships and pathways are developed, subcommittee focus will shift slightly
- Focus for the coming year (subject to change as plans are finalized):
  - Sharing national best practices around topics such as screening/triage, engagement and buprenorphine, transitions of care
  - Developing Delaware-specific best practices for EDs to reference
  - Involving health systems leadership and other stakeholders to socialize and strengthen best practices

#### Data and Quality Subcommittee Updates


- Refining inclusion and exclusion criteria for North Star metrics #1 and #2 (see next slide)
- Currently calculating North Star metrics with Medicaid claims data only, but working to include data from Delaware's all-payer claims database and prescription monitoring program
- OSOC Quality Evaluation sessions continue quarterly
  - Confidential, problem-solving meetings for EDs, EMS, community treatment providers, and State representatives to discuss clinical cases, examine relevant data, and improve referral pathways
  - QE discussions are productive, and takeaways inform OSOC goals and operations, subcommittee work, and OSOC Leadership priorities

#### Naloxone Subcommittee Updates






Total 12-Month Distribution:
