The purpose of the **PRESCRIPTION OPIOID SETTLEMENT DISTRIBUTION COMMISSION (POSDC)** is to abate and remediate the opioid epidemic in the State of Delaware through financial support from the “Opioid Fund” in the form of grant awards in an effort to treat, prevent, and reduce opioid use disorder and the misuse of opioids.

The **PUBLIC OUTREACH AND COMMUNITY INPUT COMMITTEE (the “Committee”)** has the authority to develop and propose best practices for disseminating information and gathering necessary stakeholder and public input; identify trends in data collected from stakeholder meeting and public outreach efforts; and monitor, make recommendations and periodically report to the Commission.
