CALL TO ORDER

Dr. Cowan called the meeting to order at 8:45 a.m.

REVIEW OF MINUTES

A motion was made by Ms. Morrison, seconded by Ms. Kaza, to approve the June 4, 2009 minutes as presented. The motion was unanimously carried.

UNFINISHED BUSINESS

PTD Hearing – Dr. Michael Milman, D.C.

Ms. Hickey stated that the purpose for the hearing was to give Dr. Milman an opportunity to testify and provide the Board with details regarding the incident that resulted in the administrative penalty and a probationary license in the State of California. Because of the disciplinary action, the Board had proposed to deny Dr. Milman's application by reciprocity. Dr. Milman participated via telephone. The Board was introduced. The Board exhibits were entered into evidence. Dr. Milman was sworn in and gave his testimony.

The Board went off the record for deliberations. After deliberations, the Board went back on the record.

A motion was made by Dr. Cowan, seconded by Dr. Travis, that Dr. Michael Milman's administrative penalty imposed by California was not a grounds to deny licensure and that his application was approved. Ms. Morrison and Ms. Kaza abstained. The motion carried.

CE Reviews

Dr. Daniel E. Collins was ordered to submit proof of completion of the required continuing education requirements. Dr. Collins submitted his documents for Board review.

A motion was made by Dr. Baldt, seconded by Dr. Cowan to approve the submission as completion of his continuing education requirements.

The Board reviewed the certificates submitted by Dr. Lynn Walsh for Board review and approval. The Board tabled the review pending receipt of the course content, course outline, and instructor resumes for the courses submitted.

The Board reviewed the correspondence that was submitted by Dr. Desiree Steimel after she received a post renewal audit letter, which stated that she was not required to complete any continuing education this renewal, however, according to Rule 4.4.1, she would owe 18 CEs. The Board Counsel advised to schedule a rule to show cause hearing.

Strategic Plan, Regulatory, and Statute Amendments

The Board discussed their strategic plan to include statute and regulation changes to topics such as reciprocity, licensure requirements, and automatic approval of Chiropractic continuing education courses provided by Board pre-approved, accredited schools of Chiropractic. The Board will continue working on the amendments at future meetings and would like to have their proposed Statute changes submitted for the next Legislative session.
