October 20, 2009**

The Delaware Thoroughbred Racing Commission held a regular meeting on Tuesday, October 20, 2009, at 10:00 AM, in the second floor conference room of the Horsemen's Office located on the grounds of Delaware Park, 777 Delaware Park Boulevard, Wilmington, Delaware 19804.

1. **WELCOME & CALL TO ORDER**
Chairman Daney called the meeting to order at 10:15 AM and welcomed those in attendance.
2. **APPROVAL OF MINUTES**
Upon a motion duly made (Stegemeier) and seconded (Killeen) minutes of September 22, 2009 were approved as submitted.
3. **OLD BUSINESS**
 - A. **4mm Toe-Grab Emergency Rule**
Executive Director Wayne reminded Delaware Park that the DTRC emergency rule expires October 21, 2009.

Delaware Park Senior Vice President and General Counsel, Mr. Vild, stated written notice was forthcoming to the Commission from Delaware Park indicating Delaware Park's house rule adoption was already in place and is consistent with the DTRC's emergency regulation.
4. **NEW BUSINESS**
 - A. **Request for 2010 Live and Simulcasting Dates**
Delaware Racing Association requested 363 days of simulcasting from January 1, 2010 to December 31, 2010. In addition they requested 116 days of live racing. Harty and Harty will be the auditors and Scientific Games' Autotote subsidiary is under contract to provide tote services. The engineers and insurance reports will be provided as required.

Upon a motion duly made (Decker) and seconded (Stegemeier) approval was granted as submitted.

Mr. Mooney reported someone on his staff in the Racing Office would be available to assist with compliance of the Shock Wave Therapy DTRC Rules and House Rules..

Executive Director Wayne reported a State Commission Veterinarian would be available on the same paid basis as previous years.

Dr. Peters reported two deaths in September 2009 – both horses were wearing 2mm or queen's plate. Three deaths from racing in October 2009 – two experienced previous knee problems; and one previous ankle problems.

Dr. Peters reported that, overall, the track and racing surface have been very good and the breakdowns are becoming less and less because of that.
